## What is Aviation Law?

- ▶ The law governing the activities that take place in airspace.
- ▶ **Air Space** : Airspace is the portion of the atmosphere controlled by a country above its territory, including its territorial waters or, more generally, any specific three-dimensional portion of the atmosphere.
- ▶ **Civil Aviation**: Civil Aircraft v. State Aircraft
- ▶ **State Aircraft** : Aircraft used in military, customs and police services.
- ▶ Every State has complete and exclusive sovereignty over the airspace above its territory.
- ▶ Navigation on the surface of the high seas and flight above such seas are free for the use of all. Over the high seas, the rules in force are those established under the Convention on International Civil Aviation, 1944 (**Chicago Convention**).
